## Integrated digital enforcement

Tanfeeth+ is setting a groundbreaking standard for digital integration and efficiency in providing judgment enforcement services. Through Tanfeeth+, Dubai Courts assists the customer in procedures related to the enforcement of judgments by establishing a seamless, transparent, and integrated ecosystem that benefits all parties.

#### Digital Writ of Execution Seal

Facilitating the enforcement of court rulings through a Digital Writ of Execution Seal, enabling the petitioner to initiate procedures without the need to visit service centers.

#### Sale Notification System

Notifying officials in charge of the execution of a judgement about items confiscated as part of a ruling so that they can be sold within a specified time frame.

#### Disclosure Platform

A digital platform integrated with various entities, allowing the enforcement judge to directly inquire about the respondent's assets and seize them for sale if necessary to settle owed amounts.

## Automatic Cancellation of Enforcement

For cancelling enforcement procedures and lifting seizures once payment is completed in the enforcement file, then notifying relevant parties to cancel related procedures.

### Integration with MOI

Ensuring the enforcement of liberty- restricting orders, travel bans, and asset seizures by integrating with the Ministry of Interior's program, where the judge's order is directly reflected in the Ministry's system.

#### Virtual Bank Accounts

Accounts for each party in the enforcement file created upon registration, enabling entities holding the seized assets to deposit funds directly into these accounts for automatic disbursement to each party.

#### **Digital Requests**

Optimising Work of Execution procedures based on procedural sequences and automatically issuing decisions on administrative requests then assigning them to specialists for execution.

#### Automated Disbursing System

A system that automatically disburses amounts deposited in the enforcement file to the petitioner's registered bank account after verifying there are no legal impediments.
